- For additional burndown and residual weed control tank mix with DuPont™ Cinch® ATZ or Breakfree® ATZ herbicide.
- For control of emerged weeds add NIS or COC.
- When tank mixed with a glyphosate or glufosinate herbicide containing a built-in adjuvant system, no additional surfactant is required.
