



DECLARE[®] Insecticide — Use it on row and specialty crops for control of a wide range of insect pests

DECLARE[®] Insecticide controls numerous insect pests such as aphids, beetles, thrips and worms. It is labeled for use on a variety of crops including alfalfa, cole crops, corn, cotton, cucurbits, fruiting vegetables, pome fruit, stone fruit, tree nuts, rice, lettuce, onions, garlic, tomatoes, legumes and more.

The active ingredient in **DECLARE** is gamma-cyhalothrin, which is the latest generation pyrethroid. It is considered to be the most active pyrethroid in the market today.

In addition, **DECLARE** can be tank-mixed with other insecticides for greater crop protection. Effective tank-mixes include **DECLARE** and **FYFANON[®] ULV AG Insecticide** for late season plant bug control in cotton, and **DECLARE** with **NUFOS[®] 4E Insecticide** for knockdown and residual control of insect pests on soybeans.

DECLARE also has an exceptionally low use rate when compared to other pyrethroids, while providing an extended period of control of target pests.

Application Information

Depending on your crop, **DECLARE** can be applied at planting or as required by scouting and then at various intervals thereafter. Timing and frequency of applications should be based upon insect populations reaching locally determined thresholds. See the product label for specific directions on rates, target pests and crops. **DECLARE** is a restricted use pesticide due to toxicity to fish and aquatic organisms. Please review the label to understand the required buffer zones needed between field edge and down gradient aquatic habitats including, but not limited to, lakes, rivers, ponds, streams, etc.



Consult label for specific direction on spray additives, re-entry interval (REI) and personal protective equipment (PPE).
