SOLIDA® Herbicide controls numerous grasses, sedges and broadleaf weeds in a variety of crops including citrus fruit, stone fruit, tree nuts, pome fruit, grapes, potatoes, potatoes grown for seed, field-grown tomatoes, and field corn.*

The active ingredient in **SOLIDA** is rimsulfuron, which controls hard to manage weeds including fleabane, marestail, barnyardgrass, woolly cupgrass and morningglory. It is rapidly absorbed through both the roots and foliage of plants stopping the growth of susceptible weeds.

SOLIDA is an inexpensive alternative to Matrix[®] and Resolve[®] herbicides, and offers long-lasting soil residual activity in labeled crops. It has excellent tree, nut and vine tolerance and won't cause injury or scarring for in-season applications. **SOLIDA** can be tank-mixed with other suitable herbicides for greater residual activity and broader weed control. It's also a great tank-mix partner for registered fungicides and insecticides. See label for recommendations.






Postemergence Performance of SOLIDA Herbicide
