RESIDUAL CONTROL OF GRASSES AND BROADLEAF WEEDS IN WINTER WHEAT

Anthem® Flex Herbicide: Benefits

- Flexible application timing: Should be applied delayed preemergence through 4th tiller growth stage.
- Excellent crop safety to winter wheat.
- Flexible use rates: 2.0-4.5 oz per acre depending on soil type.
- Long residual control of Italian ryegrass, annual bluegrass and crabgrass.
- Flexible application methods: Ground or aerial applications.
- Use across most soil types and tillage practices.
- Flexible rotational restrictions.
- Stronger, longer control and suppression of broadleaves most grass herbicides cannot match.
- Mixes easily with other labeled herbicides and insecticides.
- Limited soil pH restrictions and no herbicide or insecticide interactions.
- Excellent resistance management tool.

Application Recommendations

- Do not apply to broadcast seeded wheat.
- Plant wheat a minimum of 1 inch deep.
- Do not plant wheat over 1.5 inches deep.
- Apply prior to weed germination.
- Anthem Flex herbicide must be activated to provide control; ½ inch of rain or light incorporation required to activate.
- May be tank mixed with most post emerge herbicides.
- Adjuvant is recommended if not contained within the tank mix product, minimum of an NIS at 0.25% V/V

RESIDUAL CONTROL OF GRASSES AND BROADLEAF WEEDS IN WINTER WHEAT

Application Timing – Delayed Preemergence

- Apply as a broadcast spray to the soil surface following wheat planting when 80% of germinated wheat seed have a shoot at least ½ inch long until spiking.
- Ground or aerial application.

Application Timing – Post plant

- Apply as a broadcast spray to wheat at spiking up to 4th tiller growth stage.
- Can be applied in a tank mix with postemergence herbicides for broader-spectrum grass and broadleaf control .
