- In fields with a composite soil pH of 7.0 or less, higher rates of Envive<sup>™</sup> can be used up to 5.3 oz/A.
- For variable pH soils where the composite pH of a field exceeds 7.0, use 2.5 oz/A of Envive<sup>™</sup> for burndown and limited residual control of labeled weed species.
- Envive<sup>™</sup> can be applied early spring following ground thaw, up to three days after planting.
- Can be used in all tillage systems.
- Can be used alone or tank mixed with products such as glyphosate to enhance burndown of emerged winter annual weeds.
- For glyphosate-tolerant soybeans, follow with an in-crop application of glyphosate. As needed, add products such as DuPont<sup>™</sup> Synchrony<sup>®</sup> XP, Classic<sup>®</sup> or Assure<sup>®</sup> II herbicides to broaden weed control spectrum.
