Pennycress, field	2 to 8 inches tall
Pigweed, redroot	2 to 8 inches tall
Ragweed species: common, giant	1 leaf to 5 leaf
Smartweed: green, ladysthumb	2 leaf to 6 leaf
Sunflower, volunteer	2 leaf to 6 leaf
Thistle, Canada	Rosette to bud
