- Built-in safener technology, represented by the "Q," that provides corn growers with the flexibility to confidently apply Resolve® Q herbicide even after corn emergence.
- Faster, more consistent burndown than glyphosate alone, plus residual to get your corn herbicide program off to a strong start.
- An additional mode of action to help minimize the occurrence of certain herbicide-tolerant weeds.

Application information

- Apply Resolve® Q preplant incorporated, preemerge or preemergence burndown to field corn, tank mixed with full or reduced rates of other products registered for use in corn.
- The addition of crop oil concentrate or methylated seed oil is recommended for burndown of labeled weeds.
- Adequate soil moisture is required for optimum activity. Rainfall within 5 to 7 days after application will enhance Resolve® Q residual activity.
- Do not apply as a fallow or preemergence treatment to coarse textured soils (sand, loamy sand or sandy loam) with less than 1% organic matter.

One-Pass Program

Resolve® Q1 1.25 oz/A

- + appropriate rate of DuPont™ Breakfree® or Cinch® atrazine-containing brand herbicide (weeds and grasses 1-2" tall)
- + Abundit® Extra herbicide (glyphosate)* (weeds and grasses exceeding 2")

Two-Pass Program

Resolve® Q1 1.25 oz/A

- + Abundit® Extra* as needed
- + atrazine as needed

Followed by

Resolve® Q1 1.25 oz/A

- + Abundit® Extra* as needed
- When making applications of Resolve® Q, do not apply more than 1 oz active ingredient rimsulfuron/A during the crop year.
 Refer to the Abundit® Extra label for specific AMS and surfactant recommendations.
