# **Application information**

- For best control of morningglories and dandelion, a higher rate of Classic® is recommended.
- Refer to the Abundit<sup>®</sup> Extra (glyphosate) label for specific ammonium sulfate and surfactant recommendations.
- Classic® may be applied anytime after the first trifoliate has opened but no later than 60 days before soybean maturity.
- Classic® may be tank mixed with DuPont™ Asana® XL insecticide for control of soybean aphids (except in California), bean leaf beetles and many other insects. Refer to label for use with other insecticides.
